Subject: **Media inquiry re Notices of Intent and Reports related to Weather Modification Information Regulations**

Dear Mrs. Campbell,

Firstly, please let me congratulate and thank you for the fruits of your impressive career which has spanned over [40 years of public service](#); this level of dedication and service to Canadians is unmatched and truly remarkable as well as notably commendable.

My name is Dan Fournier and I am an independent journalist based in La Belle Province de Québec. I am currently completing an extensive article that is concerned with geoengineering and weather modification in Canada.

As was confirmed to me by Environment and Climate Change Canada (ECCC), as the Assistant Deputy Minister of the Meteorological Service of Canada, you are the *Administrator* designated as prescribed in the [Weather Modification Information Regulations C.R.C., c. 1604](#).

Moreover, ECCC has confirmed to me that “any weather modification activity undertaken in Canada must be officially reported to Environment and Climate Change Canada,” and that “Notices of Intent and Reports, as set out under Schedules I and III of the Weather Modification Information Regulations ([https://laws-lois.justice.gc.ca/eng/regulations/C.R.C., c. 1604/index.html](https://laws-lois.justice.gc.ca/eng/regulations/C.R.C.,_c._1604/index.html)), may be sent to the Administrator of the Act at the following email address: AdminLRMMT-WMIAAdmin@ec.gc.ca.”

Accordingly, I am making a general inquiry about these Notices of Intent, Records, and Reports that have been submitted to you with regards to weather modification conducted by participants involved in these programs and activities. If you can answer the following questions (**in bold**), I will be most grateful.

As you may know, in recent years, many Canadians have expressed their concerns about geoengineering and weather modification activities which have taken place in our country, particularly with regards to their impacts on their health and well-being, as well as their effects on our natural environment, including the air that we breathe and our potable water supplies.

**1) a) Roughly speaking, how many Notices of Intent, Records, and Reports about weather modification programs and activities have you received as Administrator as per the requirements set forth in the ‘Weather Modification Information Regulations’ in the last 5 years?**

**b) Is there is publicly available information about these? If so, could you please provide a link or reference to related reports and documents?**

**2) In general, what types of weather modification activities have been reported, including their types (e.g., research, activities like cloud seeding, etc.) goals, purposes, geographical areas affected, and potential or measured impacts in the last 5 years?**

**3) Have there been any such weather modification activities or programs reported to you that involved the use of chemicals, metals, or hazardous materials or substances being sprayed or released into the atmosphere – be it at ground level or in our skies (including the troposphere and stratosphere)?**

**4) Have any reprimands, punishments, or penalties been issued to parties who have not fully complied with said regulations? If so, are you at liberty to share that information?**

Once more, I would like to personally thank you for public service, “working to make Canada a better place for future generations,” as you put it; and, for your time in responding to this inquiry.

The deadline for my article is **Friday, Sept. 29**; so, if you can answer by then, I will be most grateful.

I sincerely apologise for the brief delay. If you need more time to respond, I can always add them later on to my article as an addendum.
