Dear Mrs. Lewis,

My name is Dan Fournier and I am an independent investigative journalist $^{1}\$ based in the province of Quebec.

I am writing this Open Letter to you which outlines some **key concerns** that are the result of a four part series I have just concluded and published called **Special Investigation: Geoengineering & Weather Modification in Canada**² which spans over 300 pages in length and is the result of hundreds of hours of meticulous and exhaustive research. This is a topic that is of great concern to all Canadians, including your constituents in the province of Ontario.

Due to the seriousness of the findings of my investigation, I have also written Open Letters to the Canadian Security Intelligence Service (CSIS), the Royal Canadian Mounted Police (RCMP), and the Sûreté du Québec (SQ) calling for them to conduct formal inquiries and/or investigations into some of these matters of great concern³.

The reason I have decide to write to you in particular in lieu of other MPs rests on your integrity and unmatched and track record in holding our government and its institutions to account.

I have always preferred to judge a person on their *actions* versus their words and promises. Accordingly, I have been deeply impressed by your courage to publicly speak out about issues of great importance such as the UN/WHO's

Pandemic Treaty⁴, World Economic Forum (WEF) agendas such as Digital IDs⁵ and Smart Cities⁶.

Another example of your actions includes your Petition to the House of Commons e-4623 (Foreign affairs)⁷ which seeks to "to urgently implement Canada's expeditious withdrawal from the UN and all of its subsidiary organizations, including WHO" which obtained 90,089 signatures.

Somewhat related to geoengineering/weather modification, you also issued an Order Paper Question⁸ (Q-1689)⁹ on June 20, 2023 regarding concerns to the government's engagements with the World Economic Forum (WEF). As I reported in Part 2 of my series¹⁰, the Liberal government had introduced taxes on carbon emissions (carbon taxes) to help mitigate the alleged impacts of Climate Change, but it was discovered that they had actually paid the WEF for a report to help justify their climate change policies¹¹ in order to impose said carbon taxes on the back of hard-working Canadians.

Additional evidence¹² which supports my series' Overall Conclusion lies in the admissions made by the Royal Aeronautical Society whereby they, firstly, confirm that they are using aircraft from the commercial airline industry to intentionally create [toxic] contrail-induced cirrus clouds¹³; and secondly, as per their own April 2023 Briefing Paper¹⁴, they admit that contrails and contrail-

induced cirrus clouds from aircraft have a net warming effect about 1.5 times that of aviation's CO2 emissions, and this is seemingly being done with $intent^{15}$.

Such actions demonstrate the duplicitous nature of the current Liberal government, and also undermines their stance on the true nature and impacts of climate change.

With regards to significant contributing factors, or culprits, that are contributing to atmospheric climate change, and following my extensive investigation into the matter, I have come to the Overall Conclusion¹⁶ that there exists evidence which suggests that there is a coordinated, multi-nation effort that has been taking place for well over a decade¹⁷ by the United Nations' IPCC (Intergovernmental Panel on Climate Change)¹⁸ which consists of utilising the commercial airline industry to intentionally disperse harmful metals and chemicals¹⁹ into our atmosphere under the justification of mitigating so-called, scientifically questionable²⁰, climate change.

As the Liberal government has secretly conspired with the WEF with regards to justifying the imposition of their crushing carbon taxes on Canadians, who is to say that they have not also been allowing for the illegal spraying of substances into our atmosphere (as detailed in my series)?

In my series, I have outlined a long and worrisome list of health impacts²¹ the spraying of such kinds of toxic substances²² have on humans – particularly for the elderly (such as Alzheimer's disease) and young infants (neurological damage)²³.

Over the course of the past several months, I have had several communications with Canadian agencies such as Environment and Climate Change Canada

(ECCC), Transport Canada (TC), among others²⁴. But unfortunately, these agencies have lacked transparency with regards to key concerns regarding these geoengineering and weather modification related activities²⁵.

Due to this lack of transparency (and accountability), I am, therefore, **asking** whether you would consider making Order Paper Questions to some of these agencies with regards to the concerns outlined in this Open Letter and in my investigative series.

Part 4 of my series also calls for **proposed legislation**²⁶ (as already exists in Mexico and several U.S. states) not for an outright ban, but with regards to having more transparency, verification, and accountability about geoengineering and weather modification activities. Currently, no province nor Canada as a whole has introduced such, much needed, legislation.

As an M.P., you are in the very unique and privileged position of being one of only 338 people in this country of 41 million who can actually introduce such kinds of legislation. Please note that I am willing, at my expense, to meet with you at your office should you be open to consider such a kind of draft legislation which I can assist to author that could subsequently be presented to the House of Commons.

I remain at your disposal for any additional information you would like to obtain regarding these issues of grave concern, and look forward to your reply which I will gladly append to Part 4 of my series²⁷.
